- Do not cover airflow located on the side panels while using VEEBA™

### VEEBA™ DEVICE STATUS:

#### No battery:

- When the Light pulses 10 times and Light turns off.

#### Error:

- When the Light pulses 2 times.
- When the Light turns on while puffing but there's no vape.
- VEEBA™ device is no longer operational.

## **Intended Users**

- VEEBA™ is for adult-use only.
- VEEBA™ is for adults who would otherwise continue to use tobacco or nicotine-containing products.
- Children and adolescents should never use VEEBA™ under any circumstances.
- This product should not be used by persons with reduced physical, sensory or mental capabilities, or lack of knowledge, unless they have been given supervision or instruction to use the product in a safe way and understand the hazards involved.

## **Nicotine**

- VEEBA™ contains nicotine, which is addictive.
- VEEBA™ is not risk-free. The best way to reduce nicotine-related health risks is to quit tobacco and nicotine use altogether
- Some users may experience side effects including: abdominal pain, cough, dizziness, dry mouth, headache, malaise, nasal stuffiness, nausea, mouth irritation, throat irritation, vomiting.
- Nicotine-containing products should not be used by people who have or are at risk of heart disease, are diabetic, are epileptic or are experiencing seizures.
- Nicotine-containing products should not be used during pregnancy or while breast-feeding. If you are pregnant, breast-feeding, or think you may be pregnant you should quit tobacco and nicotine use altogether.

- Stopping smoking or switching to VEEBA™ or other nicotine-containing products may require the adjustment of the dosing of certain medicines (e.g., theophylline, clozapine, ropinirole).
- If you have questions about whether you should use VEEBA™ given an existing health condition, you should consult a health care professional.

### **Battery Risks**

VEEBA™ is powered with sealed Lithium-ion (Li-ion) batteries. Under normal conditions of use, the battery is sealed. If you notice that battery fluid leaks, follow these precautions:

- If fluid from leaked battery is swallowed, seek medical attention immediately. Do not induce vomiting or ingest food or drink.
- If vapor from leaked battery liquid is inhaled, get fresh air and seek medical attention.
- If fluid from leaked battery is in contact with skin, wash hands and do not touch eyes.

- If fluid from leaked battery is in contact with eyes, immediately flush with running water for at least 15 minutes and seek medical attention immediately.

- Use VEEBA™ promptly once purchased/removed from original packaging.
- Droplets or traces of liquid may appear during usage, storage, or

unpacking of VEEBA™. Should you see droplets or traces of liquid on VEEBA™, without signs of leakage, carefully and thoroughly wipe the residue before use with a dry cloth (including the mouthpiece). Do not use if it is actively leaking, or if any droplets or traces of liquid reappear after cleaning.

- Do not use this product if the VEEBA™ appears to be leaking.
- Due to risk of VEEBA™ leaking with altitude changes, it is not recommended to fly with VEEBA™ that has been removed from packaging or has been partially used.
